U.S. LARGE-CAP VALUE

Stocks bought at a meaningful discount to business value may offer an inherent margin of safety¹ and return potential. The Fund uses a bottom-up, fundamental approach to identify companies creating shareholder value through sustainable free cash flow generation. Combining this approach with a focus on quality, growing companies with strong balance sheets should reduce downside risk.

Highest-conviction ideas with clearly defined sell discipline. Prior to purchase, stocks receive upside and downside price targets. Stocks exceeding the upside price target may be sold, while those exceeding the downside price target typically undergo a review to validate the initial investment criteria. To manage risk, the Fund limits the maximum weightings of individual securities and sectors.

Brown Advisory partners with similarly minded investment managers. We seek managers with sophisticated and disciplined research teams generating bottom-up, fundamental research. We favor long-term approaches that are rooted in high conviction and low turnover.

Terms and Definitions for Fund Characteristics

Market Capitalization is the value of the fund as determined by the market price of its issued and outstanding stock. The Weighted Average Market Capitalization of a portfolio equals the average of each holding's market cap, weighted by its relative position size in the portfolio (in such a weighting scheme, larger positions have a greater influence on the calculation). The Weighted Median Market Capitalization is the median market capitalization of a fund's equity portfolio gives you a measure of the size of the companies in which an equity fund invests. It is the trimmed mean of the market capitalizations of the stocks in the fund's portfolio. Price-Earnings Ratio (P/E Ratio) is the ratio of the share of a company's stock compared to its per-share earnings. Characteristic excludes cash. Price-Book Ratio (P/B Ratio) is determined by dividing the price of the stock by the company's book value.
