### Portfolio Comments

In April, the Brown Advisory Equity Income Composite rose 4.2% (net of fees) outperforming its benchmark S&P 500® Index, which rose 4.0%.

The portfolio's financial holdings continued to generate meaningful relative performance, as the sector was the top contributor to performance during the month. The performance of our industrial holdings also improved from the previous month and also helped drive relative performance.

Microsoft Corporation was the portfolio's top contributor to performance during the month. The company reported better-than-expected third-quarter earnings, helping to push the company's market capitalization over \$1 trillion.

Merck & Co., a health care holding, was the portfolio's largest detractor to performance during the month. Merck reported better-than-expected first-quarter earnings and also raised their outlook for the remainder of 2019. However, there are prospects regarding pricing power shifts throughout the drug and device manufacturing industries, and this sentiment weighed heavily on the stock's performance.

During April, the portfolio added two new holdings as a result of spin-offs from existing positions. Alcon, Inc., a health care holding, entered the portfolio from Novartis, and Dow, Inc., a materials company, enter the portfolio from DowDupont. [L2](#)

The strategy invests primarily in U.S. equities that exhibit above-average dividend yields, dividend growth and return on equity. The minimum account market value required for composite inclusion is \$1.5 million.
3. This composite was created in 2010.
4. The benchmark is the S&P 500® Index. The S&P 500 Index is a capitalization-weighted index of 500 stocks that is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries. ## Terms and Definitions for Representative Account Calculations

The **Average Weight** of a position or sector refers to the daily average for the period covered in this report of a stock's value as a percentage of the portfolio. The **Total Return** of an equity security is the sum of the return from price movement and the return due to dividend payments or other sources of income. Standard benchmark-, sector- and portfolio-level returns are the sums of the weights of each security multiplied by its return, summed and calculated daily and summed over the period covered by the report or by an otherwise-noted period. **Contribution to Return** is calculated by multiplying a security's beginning portfolio weight by its daily return and geometrically linking the security's daily contribution to return over the entire reporting period.
