## Portfolio Comments

The Brown Advisory Small-Cap Fundamental Value Composite fell 3.6% (net of fees) during January, outperforming its benchmark, the Russell 2000<sup>®</sup> Value Index, which fell 5.4%.

The portfolio's energy and financials holdings provided the largest contribution to return for the month. Essential Properties Realty Trust, Inc., a single-tenant property real estate company, was the strongest contributor to performance during the month. The company rose during the month due to positive support from falling interest rates.

The portfolio's consumer discretionary and utilities holdings were the largest detractors to performance in January. Hudson Ltd., a travel concession operator in the United States and Canada, was the portfolio's largest detractor to performance. The company traded down on concerns of the impact of the coronavirus.

In January, we eliminated two holdings from the portfolio.

# **Terms and Definitions for Representative Account Calculations**

The **Average Weight** of a position or sector refers to the daily average for the period covered in this report of a stock's value as a percentage of the portfolio. The **Total Return** of an equity security is the sum of the return from price movement and the return due to dividend payments or other sources of income. Standard benchmark-, sector- and portfolio-level returns are the sums of the weights of each security multiplied by its return, summed and calculated daily and summed over the period covered by the report or by an otherwise-noted period. **Contribution To Return** is calculated by multiplying a security's beginning portfolio weight by its daily return and geometrically linking the security's daily contribution to return over the entire reporting period.
