Portfolio Comments

The Brown Advisory Small-Cap Growth composite was up 4.5% during the month of February, outperforming its benchmark, the Russell 2000® Growth Index, which returned 3.3%.

Collectively, health care was the strongest sector for the month, supported by strong stock selection within the category. Establishment Labs Holdings, a global high-tech medical device and aesthetics company, led the way after reporting encouraging organic growth trends and hosting a positive customer/analyst event. Charles River Laboratories International was another positive contributor. The company is largely a pre-clinical contract research organization serving biotechnology clients that has continued to climb higher on solid fourth quarter results and a positive outlook for 2021. Other top performers on the month included Zynga and Lattice Semiconductor.

Envestnet, a leading data aggregator and data analytics platform for financial advisors, was the largest detractor from performance on the month. Although the company reported a positive fourth quarter, a surprisingly large amount of incremental expense growth to accelerate the management team's long-term vision weighed on expected 2021 cash flow growth. Investors reacted negatively to the news as the company could likely have provided more clarity ahead of time with respect to their future plans. It remains to be seen whether this heightened spending produces the desired result of accelerating revenue growth over time. In addition, ManTech International Corporation, a cyber defense contracting firm, trailed during the month.

Over the course of the month, we eliminated two positions and added four.
